tes : 1 The above financial results which are published in accordance with Regulation 33 of the SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015, as amended, have been reviewed by the Audit Committee and approved by the Board of Directors at their meeting held on May 30, 2022. The reviewed financial results are in accordance with the Indian Accounting Standards (Ind AS) as prescribed under Section 133 of the Companies Act, 2013, read with rule mide thereunder. These results have been audited by the statutory auditors of the Company.

- 2 Pursuant to the provision of Regulation 32(1) of the Securities and Exchange Board of India (Listing Obligation and Disclosure Requirements) Regulation. 2015 ["Listing Regulations) there were no public issue, right issue, preferential issue etc. for the year ended March 31, 2022 hence submission of statement of deviation or variation is not applicable.
- 3 In view of accumulated losses, no provision for current tax has been made during the year. The Company is not required to provide for MAT Liability as per the provisions of Para (vii) of Explanation 1 of section 115/B of the Income Tax Act, 1961. Hence, the same is not provided. In absence of certainty of fature profitability of the Company, the management as a matter of prudence has not recognised the Deferred Tax Assets.
- 4 The Company has identified the information as required under the Micro, Small and Medium Enterprises Act, 2006 and has only une party. Since the amount payable is under dispute due to deficiency in RM quality provided by them, the management has decided nut to provide for interest amounting to Rs. 0.75 lakts payable for the current quarter. The Total Interest liability not provided till March 31, 2022 was Rs 24.85 Lakts.

5 The Company is engaged in manufacturing of Calcium Carbonate which is considered the only reportable business segment, as per Indian Accounting Standard 108 'Segment Reporting': hence segment reporting is not given.

- 7 The Company has assessed the possible impact of COVID-19 on its financial statement based on the internal and external information available upto the date of these financial results and concluded that no adjustment is required in these results. The Company continues to monitor the future economic conditions.
